Doctor Academy – Privacy Policy

This Privacy Policy applies to Doctor Academy and its services — including the website, platform, modules, courses, and any related applications. It explains how user data is collected, used, and protected.

1. Collected Data

1.1 Personal Data

We may collect the following personal data:

- Full name
- Email address
- Phone number
- Identity documents (if applicable)
- Account information

1.2 Technical Data

We may collect technical information such as:

- IP address
- Device type and operating system
- Browser type and version
- Uploaded files and their metadata
- Interaction logs with the platform

1.3 Usage Data

We may collect data on:

- Browsing history within the platform
 - Course activity and progress
 - User preferences
 - Submitted requests or feedback

2. Purpose of Data Collection

The data is collected to:

- Provide and improve platform services
 - Process payments and course enrollments
 - Ensure smooth and secure platform operations
 - Prevent fraud and unauthorized access
 - Communicate with users efficiently

3. Platform Usage Rules

Users are expected to:

Users must:

6. Payment Rules

Users must:

 - Confirm orders before payment

7. Content Rules

 - Users must not upload illegal or prohibited content

- Some services may be linked to external providers (e.g., AliExpress)
- Doctor Academy is not responsible for policies of external websites
- Users should review external platforms' privacy policies before use

10. Communication Rules

- Users may receive updates and notifications through the platform
